# TROJMUN Privacy Policy

TROJMUN (further as "event") collects all data in accordance with data protection laws stemming both from Czech and EU law. All data is collected processed and managed by TrojMUN z.s.

TROJMUN2026 refers to an event organized by TrojMUN z.s. in March of 2026.

### I. Data we collect

- A. The data collected is in relation to the TROJMUN2026 event and can be collected through online activity on www.trojmun.cz (further as "website"), questionnaires, google forms, or other sources. We may collect the following kinds of data:
  - 1. Full name
  - 2. Contact details (email address, phone number)
  - 3. Gender and pronouns (voluntary)
  - 4. Dietary needs and preferences
  - 5. School or institutional affiliation
  - 6. Role and participation details (position *chair/ delegate*, committee and country preference, etc.)
- B. Personal data is stored on internal, secure platforms and is accessible only to authorized members of the organizational team as required for event operations. Data may be shared with government authorities or third parties only if required by law or in case of emergencies.
- C. All data that we collect will not be stored longer than necessary and no longer than 5 years, unless you request to have your data deleted.

#### II. Data utilization

- A. We use your data for the following reasons:
  - 1. To facilitate smooth operations and services in regard to any aspect that may affect you during the event.
  - 2. To create statistics and help us better understand your needs with regard to improvements in future events.

- 3. To establish a communication channel with you so that you can get all of the necessary information that will be crucial for your attendance at TROJMUN2026.
- 4. To identify and process your registration, as well as your assigned role.
- 5. Photographs, video, and audio recordings along with other similar items may be used for promotional purposes.

# III. Your rights

In accordance with GDPR, you have the following rights regarding your personal data:

- 1. Right to Access: You can request a copy of the personal data we hold about you.
- 2. **Right to Rectification**: You can request correction of any inaccurate or incomplete information.
- 3. **Right to Erasure ("Right to be Forgotten")**: You can request deletion of your data unless we have a compelling legal reason to retain it.
- 4. **Right to Restrict or Object to Processing**: You can limit or object to certain types of data use.
- 5. **Right to Data Portability**: You may request to receive your data in a commonly used, machine-readable format.
